Thomson, City of Benbrook, U.S. Army Corps of Engineers, Triple T Ranches, Inc., a Texas corporation d/b/a Benbrook Stables and its or their employees, agents, officers, directors, and owners (hereinafter collectively referred to as "Management") harmless from and against any liability for any injury, loss or death suffered while on the premises or while engaged in any activity whatsoever or in any location whatsoever that is in any way associated with Management, and from and against any and all claims, losses, liabilities, attorneys' fees, medical fees, costs and expenditures incurred by or asserted against Management, and from and against any and all claims including claims for injury or loss suffered, whether or not such injury or loss resulted directly or indirectly, from any reason including, but not limited to, the negligent or grossly negligent acts or omissions of Management. In other words, I AGREE TO DEFEND, INDEMNIFY AND HOLD MANAGEMENT HARMLESS FOR ITS OWN NEGLIGENCE, CONTRIBUTORY NEGLIGENCE AND GROSS NEGLIGENCE.

#### **Payments**

All payments must be made by cash or check.

#### **Date Changes**

All date changes are subject to a \$75 change fee. This amount does not go towards your balance. In the event the date change is made within 30 days of the event, a new deposit may be required.

#### **Cancellations**

If the event is cancelled 30 days or more before date, all payments except your deposit will be returned. All cancellations within 30 days of the event date will result in a forfeit of all monies paid. Monies paid for event planner will not be returned no matter when cancellation occurs. Cleaning deposit will be returned in the event of a cancellation.

#### **Cleaning/Damage Deposit**

A \$75 cleaning/damage deposit is required for all events in the Cantina. This must be paid as your initial deposit, and will be returned to CLIENT(S) no sooner than one week after the event, pending inspection of the venue. #### Alcohol

A police officer is preferred at all events when alcohol is being served.

#### **Smoking**

Benbrook Stables is a non-smoking facility. Your cleaning fee of \$75 will be forfeited if smoking occurs. Cigarette butts left anywhere will result in forfeiting your cleaning deposit.

#### **Unloading / Loading**

No rice, bird seed, food, balloons, wish lanterns, potpourri, or glitter allowed. Please check with management for verification on anything other than bubbles, ecofetti, ribbon wands, glow sticks or sparklers.

#### **Glass Breakage**

All parties are to use appropriate designated roads and parking lots only. No vehicles should ever be on the grass. Not for parking or even turning around.

#### Cleanup

All items brought in by you, your vendors or your guests will need to be removed. All of the tables and chairs must be cleaned and stacked.
